In 1957, Edward F. Steigerwaldt, Sr., established Edward Steigerwaldt, Consultant Forester, in Tomahawk, Wisconsin. Ed designed his business to emphasize forest management, timber sale facilitation, aerial photograph interpretation, general land consulting, and Christmas tree farming.

His son, Ed Jr., joined the company in 1970, creating Edward Steigerwaldt and Son, Consulting Foresters. Expanding the business to include timber inventory and real estate appraisal, they successfully completed a succession of notable inventory and mapping projects throughout Wisconsin and Michigan. The business gained a reputation for high-quality work and a commitment to forest stewardship. As additional services were offered and staff grew, in 1987, the business alteredits name to Steigerwaldt Land Services, Inc. (Steigerwaldt).
