### TIMBER SALE PREPARATION AND ADMINISTRATION

From start to finish, our foresters will oversee your timber harvest. Beginning with establishing harvest boundaries, we will designate the trees to be marked, develop maps and a prospectus to market your timber to active loggers, and take

care of all the paperwork. Your timber harvest will be monitored until all the wood is delivered, the roads are returned to the same or better condition, and you receive the accurate payments for your wood.

### TIMBER ACCOUNTING

Using electronic monitoring and a load tracking system, we follow each load of wood that leaves your property, ensuring you earn the maximum value for your asset.

### WOOD PRODUCT MARKETING

We evaluate harvestable timber and provide landowners accurate details on the volume for each product class available to be sold, as well as an estimate of the value. Our foresters will also work with you to find a buyer for your timber, soliciting multiple bids from active loggers in your area.

### PROPERTY MANAGEMENT

Our foresters actively listen to landowners, working to understand the objectives for their property, and helping the landowner achieve those goals by outlining a workable plan for them to implement.

### TAX INCENTIVE PROGRAMS

*(Wisconsin MFL/FCL, Ohio FTL, Michigan CF, Minnesota SFIA, NRCS cost-sharing)*

Landowners are provided reduced property taxes for managing their forestlands according to sound forestry practices. Our foresters prepare

the management plan that both satisfies the landowners' objectives and incorporates sound forestry practices.

### BEST MANAGEMENT PRACTICES (BMP) MONITORING

We oversee forest management activities to ensure valuable assets, such as water features, are protected and precautions are taken to limit the impact of invasive species.

### TREE DISEASE DIAGNOSIS AND PROTECTION
